The qualification fixed for the post of Accounts Officer, created as per the Government Order read above, is "experienced Chartered/Cost Accountant" and the method of appointment is on "contract basis" and the salary fixed is "consolidated pay of Rs. 15,000/-" Since the service of an Accounts Officer is highly essential for Kerala State Coastal Area Development Corporation and it is difficult to obtain such a qualified person in such a lower salary as ordered in the above read Government Order, the Managing Director, Kerala State Coastal Area Development Corporation, as per the paper read as 2<sup>nd</sup> paper above has requested relaxation of qualification to the post of Accounts Officer from experienced Chartered/Cost Accountant to Intermediate Examination of Chartered/Cost Accounts Course or B.Com with 5 years experience or M.Com with 2 years experience in a Company/Organization looking after Accounts matter.

Government have examined the matter in detail and are pleased to relax the qualification fixed for the post of Accounts Officer in Kerala State Coastal Area Development Corporation created as per the Government Order read as 1<sup>st</sup> paper above as pass in Intermediate Examination of Chartered/Cost Accounts Course or B.Com with 5 years experience or M.Com with two years experience in a Company/ Organisation looking after accounts matter.
