**ORDER**

As per Government Order read as 1<sup>st</sup> paper above, Administrative Sanction was accorded for the NCDC approved Integrated Fisheries Development Project 2017-18 at a block cost of ₹4504.80Lakh to be implemented by Matsyafed through Primary Fishermen Co-operative Societies. Later on an amount of ₹578.68Lakh was sanctioned as per Government Order read as 2<sup>nd</sup> paper above. NCDC further released an amount of ₹684.29Lakh towards the loan component as advance for the implementation of IFDP 2017-18, out of which an amount of ₹578.68Lakh was released to Matsyafed.

**2.** The Director of Fisheries in his letter read as 3<sup>rd</sup> paper above requested for the release of the balance amount of ₹105.61 Lakh to Matsyafed towards the loan component under the Head of Account 6405-00-195-99(loan) for the implementation of NCDC assisted IFDP 2017-18 to Matsyafed from the budgetary allocation of the current financial year 2019-20.

**3.** Government have examined the matter in detail and are pleased to accord sanction for the release of an amount of ₹105.61 Lakh (Rupees One Crore Five Lakh Sixty one Thousand only) to Matsyafed from the budget provision of 2019-20 under the Head of Account 6405-00-195-99(P) subject to the terms and conditions of fund release given below.

1. The amount shall not be parked in Banks /Financial Institutions other than treasuries as non interest bearing STSB accounts.
2. The instructions stipulated in Cir.No.75/09 dated 29/08/09, Circular No 84/2008/Fin dated 09/12/2008 shall be scrupulously followed.
3. A duly authenticated detailed component wise statement of Expenditure and utilisation Certificate in the prescribed form as appended to the GO(Ms)No.451/2018/Fin dated 28.11.2018 shall be furnished.
4. If there is un-utilised amount at the end of this financial year that should be refunded to Government during the financial year itself.
