**ORDER**

In the letter read as 2nd paper above, Registrar, Kerala University of Fisheries & Ocean Studies has requested to release an amount of `364.35Lakh from the budget allocation of `1457.40Lakh for 2018-19 as Grant-in-aid to Kerala University of Fisheries and Ocean Studies for meeting the immediate requirements of Salary, TA and other contingencies in the 3<sup>rd</sup> quarter of 2018-19.

Government have examined the matter in detail and are pleased to accord sanction to release the third instalment of `3.6435Crore (Rupees Three Crore Sixty Four Lakh and Thirtyfive Thousand Only) to Kerala University of Fisheries & Ocean Studies under the head of account "2415-05-277-99-31-Grant-in-Aid-General-Salary(NPV)" for meeting the requirements of the salary, TA and other contingencies in the 3<sup>rd</sup> quarter of 2018-19 subject to the usual terms and conditions of fund release.

- a. Funds should not be parked in banks or any other financial institutions.
- b. Funds should be used for the specific purpose for which it is released and not diverted for any other purpose.
- c. Utilization Certificate along with component-wise expenditure statement as stipulated in the GO(P) No. 82/2018-FIN dated 06/03/2018 should be furnished, along with the request for next

release.

- d. Statement with details regarding the STSB account for non-plan fund and the remaining balance should be furnished along with the request for next release.
- e. Instructions issued in Circular No. 84/2008/Fin. dated 9/12/2008, Circular No. 75/2009/Fin. dated 29/08/2009 and Circular No.08/2018/Fin dated 30.01.2018 should be scrupulously followed.
