ORDER

As per GO read as 1st paper above, NCDC has approved Integrated Fisheries Development Project 2014-15 at a block cost of ` 4242.66 Lakhs and as per GO read as 2nd paper above, Administrative Sanction was issued for the implementation of the same, of which Rs.964.98 is the subsidy component. As per the 3rd and 4th paper read above, an amount of ` 421.805Lakh was released to Matsyafed out of the total amount of ` 964.98 lakh towards the subsidy component of NCDC assisted Integrated Fisheries Development Project 2014-15. As per letter read as 6th paper above, NCDC approved Integrated Fisheries Development Project 2015-16 at a block cost of ` 4,889.66 lakh and as per the Government Order read as 6th paper above, Administrative Sanction was accorded for the implementation of the same of which ` 590.50Lakh is the subsidy component and ` 500Lakhs is CSISAC Grant. Director of Fisheries in his letter read as 7th paper above, has requested to release the balance subsidy amount of ` 543.175Lakh towards the subsidy of NCDC assisted Integrated Fisheries Development Project 2014-15 and an amount of ` 1,090.50Lakh towards the subsidy of NCDC assisted Integrated Fisheries Development Project 2015-16,

thus a total amount of ` 1,633.675Lakh.

Government have examined the matter in detail and hereby sanction the release of an amount of ` 16,33,67,000/- (Rupees Sixteen crores Thirtythree Lakhs and Sixty seven thousand only) provided through SDG under the H/A 2405-103-82-33(p) for clearing the pending subsidy amount under IFDP 2014-15 and IFDP 2015-16 for claiming reimbursement from Government of India.
