As per the letter read above, Director of Fisheries has submitted the project proposal for the renovation of two ornamental fish culture hubs of Center for Fresh water Aquaculture, Neyyardam with a total cost of Rs. 83.50 lakh. The project is intended to produce good quality ornamental fish seeds and to support the ornamental fish farmers, aquarium entrepreneurs, hobbyists, ornamental fish exporters and aquaculture students/researchers etc. It is proposed to renovate hub No. 7 & hub No.8 through Kerala State Coastal Area Development Corporation for an estimate of Rs. 43 lakh and 40.50 lakh respectively. The main components of the work includes renovation of existing cement tank, epoxy painting of tanks, roofing, plumbing works etc. The expenditure can be met from the head of account 4405-00-101-95-34(P) under the state budget provision. Director of Fisheries has requested to issue administrative sanction for the proposal for the renovation of two ornamental fish culture hubs of Center for Fresh water Aquaculture, Neyyardam with a total cost of Rs. 83.50 lakh.
