

Sub: Conduct of Two years of Skill Development Training Program namely Vessel Navigator Course (VNC) & Marine Fitter Course (MFC) duly recognized by DGT, New Delhi- Request for sponsorship-reg.

Sir.

It is to inform that CIFNET is the nodal agency under Ministry Animal Husbandry and Dairving (Department of Fisheries), New Delhi for developing skilled manpower required for the oceangoing/deep-sea fishing vessels. The Institute conducts two year Vessel Navigator Course (VNC) and Marine Fitter Course (MFC) under the recognition of DGT, New Delhi These are only two courses in the country with NSQF level 5 which enables the passed out candidates to acquire competency certificates under DG Shipping, Mumbai for serving onboard fishing vessel as Engine Driver, Fishing Engineer, Boson and Skipper which are mandatory for deep sea fishing vessels of more than 24metre length. The passed-out students also join in the fishing vessel initially as Junior Deckhands and Engine Room Assistants who work initially in the crew level for various deep sea fishing activities, Engine Operation and maintenance under the supervision of Skipper/Chief Engineer.

These courses enable the passed out candidates to serve onboard the deep sea fishing vessel which help them to acquire practical knowledge and Competency to become Skipper/Chief Engineer in their career path. Therefore, it is requested that the fishermen youth may kindly be encouraged and sponsored for admission in the forth coming batch of Vessel Navigator Course and Marine Fitter Course likely to be commenced from August 2024 at this Institute and our unit offices at Chennai and Vizag. In this regard, it is to inform that 04 seats each for Vessel Navigator Course/Marine Fitter Course are reserved for sponsored candidates of the State Govt/UTs for undergoing training at three centre of CIFNET at Kochi/Chennai/Vizag. It is also to request that the candidates who are fulfilling the eligibility criteria mentioned below for admission to the course of VNC/MFC may be sponsored. The expenditure for the training to the sponsored candidates mentioned below has to be borne by the respective State Government/UTs. In addition to this, an amount of Rs.1500/- per month has to be paid to the sponsored candidates as stipend by the sponsorer towards the messing/hostel cost etc.

	examination should be enclosed with application even if candidate possesses
	higher qualification.
Age Limit	15 to 20 years as on 01.08.2024. Candidates born between 02.08.2004 and
	02.08.2009(both days inclusive) are only eligible for admission.
Physical	Candidates should be physically fit for strenuous work on board fishing
Fitness	vessels. In this case of Vessel Navigator Course, they need to pass the new
	entry standard sight test conducted by the authorized Doctor of DG Shipping
	before admission.

On completion of this course, the passed out students including sponsored candidates in State Government/UT's are offered post institutional training at CIFNET/FSI vessels with monthly stipend of Rs.20,500/- plus one time uniform allowance of Rs.2,500/- with signing of bond accordingly. It is therefore requested that the list of sponsored candidates may be sent to this Institute before 14.06.2024 so as to finalize the sponsorship.
