ORDER

As per Government Order read as 1 st paper above, Administrative Sanction was accorded for the Annual Plan Proposal 2023-24 of Kerala University of Fisheries & Ocean Studies (KUFOS) at an outlay of Rs.3350 Lakhs under five components, viz., Education, Research, Extension, Administration and Infrastructure and as per Government Order read as 2nd and 3rd paper above, an amount of Rs.2 Crore each and Rs.1.5 Crore each respectively, from the Head of Accounts 2405-00-188-99-35(P) and 2405-00-188-99-36(P) have been released for settling the pending bills & for meeting expenses of administration & infrastructure development.

- 2) As per letter read 4th above, the Registrar, KUFOS, has requested to release an amount of Rs.10 Crore (Rupees Ten Crore only) from the Administrative sanction received for the current financial year by debiting the Head of Account 2405-00-188-99-35 and 2405-00-188-99-36.
- 3) Government have examined the matter in detail and are pleased to release **Rs.50 Lakh (Rupees Fifty Lakh Only) each** from the Head of Accounts 2405-00-188-99-35(P) & 2405-00-188-99-36(P) to KUFOS, subject to the following usual terms and conditions of fund release;
 - i. Funds should not be parked in banks or other financial institutions.
 - ii. Funds should be used for the specific purpose for which it is released and not diverted for any other purpose.

- iii. Utilization certificate along with detailed component wise expenditure statement should be furnished along with the request for next release.
- iv. Instructions issued in Circular No. 84/2008/Fin dated 09.12.2008 and Circular No. 75/2009/Fin dated 29.08.2009, Circular No.01/2021/Fin dated 04/01/2021 should be scrupulously followed.
