<u>ORDER</u>

As per the letter read 1st paper above, The Director of Fisheries has furnished Project Proposal for Brackish Water Finfish Farming at MSF Poyya and Eranholi Farms of ADAK for an amount of Rs.112 lakhs under the Head of Account 4405-00-101-90(P) and has requested sanction for the same. ADAK is the implementing agency and period for the project is 12 month. The project is proposed to be implemented at MSF, Poyya, Thrissur and Eranholi Fish Farm, Kannur in the newly developed/renovated ponds were earlier Government aid were not received as operational cost.

The objectives of the project are as follows:

- To cover additional water spread areas available in farm units of ADAK for fin fish production.
- To enhance the availability of brackish water fin fish production in ADAK units
- To promote brackish water aquaculture among farmers and also in the state.
- To attract more entrepreneurship in brackish water aquaculture
- To give technical guidance and training for brackish water fin fishes to farmers
- Promote scientific fish farming
- To facilitate the effective utilization of the available water resources for the production of Fishes.
- To ensure the availability of quality food fish in the domestic market.
- To improve the socio economic conditions of the fisherfolk/fish farmers. The financial details of the project are as follows:

2. The Departmental Working Group meeting held on 09.05.2019 discussed the proposal in detail and decided to approve the same subject to the following conditions.

- Stores purchase rules should be strictly followed for all purchases. In the case of temproary staff , the contract pay should not exceed the pay approved by the Finance department for each category.
- The savings after implementation including equipment purchase may be remitted back to government account.
- Equipment purchase should be done as per approved rates/competitive rates.

Considering the recommendation of the Departmental Working Group Government are pleased to accord Administrative sanction for the proposal for Brackish Water Finfish Farming at MSF Poyya and Eranholi Farms of ADAK for an amount of Rs.112 lakhs (Rupees one crore twelve lakh only) under the Head of Account 4405-00-101-90(P) in the current financial year subject to the conditions specified above.
