ORDER

The Managing Director, Vizhinjam International Seaport Limited (VISL) as per letter read as 1st paper above requested Government to sanction an amount of Rs. 1,600 crores for the year 2018-19 from the provision under the head of account of Major Infrastructure Development Projects ([XXVII] 5475-00-800-92) to meet various expenditures in connection with the development of Vizhinjam International Deepwater Multipurpose Seaport Project .

The High Powered Committee met on 05.06.2018 considered the proposal on the basis of Administrative Sanction and as per the Government Order read as 2nd paper above, recommend to release an amount of Rs. 20 crores to meet the expenditures for implementation of rehabilitation activities connected with the Vizhinjam International Seaport limited under the Head of Account '5475-00-115-99(P)'

Government as per the Government Order read as 3rd paper above have authorized an additional an amount of Rs. 20,00,00,000/- (Rupees Twenty Crore Only) under the Head of Account 5051-01-001-99 (PV)- Development of Vizhinjam International Deepwater- for clearing pending applications in connection with rehabilitation package of Vizhinjam International Deep Water Multipurpose Sea Port Project.

The Director of Ports is requested to draw and to transfer credit the amount into the Special TSB A/c. No. 701041400009063 maintained for the purpose at the Sub Treasury, Vellayambalam, by the VISL. He will also take timely steps to regularise additional expenditure through Re-appropriation of savings within the grant/ Supplementary Demands for Grants before the close of the current Financial Year.
