## <u>ORDER</u>

As per letter read as 1st paper above, the Registrar, Kerala University of Fisheries & Ocean Studies furnished proposal for the Reimbursement of Claim amounting to Rs 62,65,836 towards the cost of work done from 05/2021 to 09/2021 in respect of the project Construction of Academic Block. The approved cost of the project is ₹4412.32 Lakh and the NABARD assistance is ₹3750.47 Lakh. The total Cost of work done upto 09/2021 is ₹27,03,04,915/- and the amount now claimed is ₹62,65,836/-

2. Government have examined the matter in detail and are pleased to accord sanction to release an amount of **₹39,94,000/-** (**Rupees Thirty Nine lakh and Ninety Four Thousand only)** to KUFOS as NABARD assistance to the project "Infrastructure works related with Multi-species marine fish hatchery (fish seed farm), Marine fisheries school at Puduveypu and balance works to the buildings related to research and academic purposes at KUFOS campus in Panangad (P2016960000000000102) " under RIDF XXI by debiting to the H/A 2415-05-277-98(PV), under which the amount was additionally authorized as per the Government order read as 2nd paper above and subject to the following terms and conditions.

a.Funds should not be parked in banks or any other financial institutions.

b.Funds should be used for the specific purpose for which it is released and not diverted for any other purpose.

c.Utilization Certificate along with component-wise expenditure statement

should be furnished, along with the request for next release.

d.Instructions issued in Circular No. 84/2008/Fin. dated 9/12/2008 and

Circular No.75/2009/Fin. Dated 29/08/2009 should be followed scrupulously.

e. The amount additionally authorized should be regularized either through reappropriation or through SDG during the current fiscal year.
