#### **ORDER**

As per the letter read as 1<sup>st</sup> paper above, Government submitted a proposal of Integrated Fisheries Development Project (IFDP) 2017-18 to the National Co-operative Development Corporation (NCDC) for sanction with a total outlay of `4504.80 lakhs to be implemented through Matsyafed.

#### **Objectives of the project**

- To increase the net income of the fishermen
- To increase the auction coverage of the traditional fishermen, thereby realizing better value for the catches and also to reduce the operational cost of fishing.
- Intervention in the secondary marketing chain and better realization for the produce of the member fishermen.

- To develop the Primary Co-operatives as self-reliant profit centres through service marketing.
- To remove the fishermen from their indebtedness to the local money lenders and thus ensure that they get value for their catch.
- To create awareness among members in social participation and institutionalization.
- To strengthen the primary Co-operatives thereby enabling them to be self sustained units.

### **Implementing Agency & Period of Completion**

The project is proposed to be implemented by the Kerala State Co-operative Federation for Fisheries Development Limited (MATSYAFED) through its affiliated primary co-operative societies functioning in the 10 districts (9 maritime districts & 1 inland district) of the State and monitored by Director of Fisheries. The period of implementation of the project is one year.

- 2. As per the letter read as  $2^{nd}$  paper above, the Managing Director, NCDC, conveyed the approval of NCDC at a block cost of `4504.80 lakhs. As per the letter read as  $3^{rd}$  paper above, the Director of Fisheries requested to accord administrative sanction for the implementation of the project amounting to a block cost of `4504.80 lakhs under the Heads of Accounts 6405-00-195-99(Loan), 2405-00-103-80(p)(Share) & 2405-00-103-80(p)(Subsidy) by placing the matter before Special Working Group for the consideration . The proposal was approved by the Special Working Group during its meeting held on 07.08.2018.
- 3. In the circumstances, Government are pleased to accord Administrative Sanction for implementation of NCDC assisted Integrated Fisheries Development Project 2017-18 at a block cost of '4504.80 lakhs with the component-wise details specified above, under the Heads of Accounts 6405-00-195-99, 2405-00-103-82 & 4405-00-103-98, subject to the following conditions.
  - 1. Fund required for interest subsidy and share capital shall be provided under the respective head through re-appropriation.
  - 2. The fund release shall be based on actual requirement and the fund released should not be parked in banks.
  - 3. Store Purchase Rules shall be strictly adhered to.
  - 4. Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
  - 5. For Civil works, CPWD rates shall be followed.
  - 6. Post creation and purchase of vehicles are not admissible under the scheme.
