ORDER

Government of Kerala signed a Concession Agreement (CA) with Adani Vizhinjam Port Private Limited (AVPPL) on the 17th of August, 2015 for the development and operation of Vizhinjam International Deepwater Multipurpose Seaport Project on Design, Build, Finance, Operate, Transfer (DBFOT) basis.

2. As per Clause 10.3.4 of the Concession Agreement, it is the obligation of the Authority (Government) to hand over the land to the Concessionaire. An extent of 86.2809 hectares of land has already been acquired and handed over to Adani Vizhinjam Port (P) Ltd. which had been taken over under negotiated purchase by the mutual agreement of land value and rehabilitation scheme to the land owners.

3. An extent of 4.2818 hectares of land is still to be acquired. These land owners are not ready to hand over land under negotiated purchase. Therefore, the District Collector, Thiruvananthapuram as per letter read as 2nd paoer above proposed that the remaining land (4.2818 hectares) is to be acquired under the provisions of Right to Fair Compensation & Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013 and requested to accord sanction to proceed with acquisition.

4. Government have examined the matter in detail and are pleased to accord sanction to the District Collector, Thiruvananthapuram to proceed with acquisition of an extent of 4.218 hectares of land comprised in Vizhinjam and Kottukal villages of Thiruvananthapuram District, under the provisions under Right to Fair Compensation & Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013.
