ORDER

As per the Government Order read as first paper above, Administrative Sanction was accorded for the implementation of the project "3R package for ensuring sustainable livelihood for fisherwomen in Kerala (Rebuilding, Revival, Reforms)" with a total outlay of Rs.178 Lakh under the Head of Account 2405-00-103-80 (P) for the period 2018-19. One of the major components under the project is formation of 200 JLG's (Joint -Liability Groups) covering 1000 working fisherwomen in Kollam and Alappuzha districts ensuring credit to the JLG's by bank linkage and providing margin money assistance.

As per the letter read as 2<sup>nd</sup> paper above, the Director of Fisheries has reported that the process for the beneficiary selection procedures are fast progressing and the procedures for the selection of facilitators for this project is on its final stage and a proposal has already been submitted to AGM, NABARD for giving approval for the JLG formation and to include JLG's under their LTRCF & KCC schemes for the implementation of the project and requested to release an amount of Rs.100 Lakhs from the Budget provision of the current financial year from Head of Account 2405-00-103-80 (P) to the PSTSB Account No. 799012700000787 of Executive Director, SAF for the time bound implementation of the project.
