#### 1. INTRODUCTION

Agency for Development of Aquaculture, Kerala (ADAK) is an Agency incorporated under the Act XII of 1955 being the act for the Registration of Literary, Scientific and Charitable Societies in the erstwhile Travancore-Cochin area of State of Kerala) functioning under the Department of Fisheries, Government of Kerala with its Head office at Vazhuthacaud, Thycaud P.O., Thiruvananthapuram- 695014. The Agency has the mandate to implement various programmes for the promotion of aquaculture activities within Kerala State.

The prime objective of ADAK is the formulation and implementation of aquaculture development projects in the State aimed at increasing fish production and employment generation. The agency operates farms, hatcheries, aquariums and aquatic animal health labs. ADAK has got vast experience in implementing and organizing aquaculture projects and is one of the front line institutions of the State engaged in the extension activities of aquaculture and related activities. ADAK is the nodal agency which distribute various farming inputs especially fish required for various aquaculture projects implemented by seed and feed, Department of Fisheries, viz., JMK, PMMSY, Subiksha Keralam etc. estimated annual fish feed requirement for the state is 50,000 tons, and as of now the same is procured from various dealers either directly by the farmers or through ADAK, who procure the same by inviting e-tenders. As ADAK find it difficult to get competitive price bids for its own use at farms and also for the beneficiary farmers under various projects, alternate options to procure the same directly from feed manufactures are being explored. As the feed cost is the ultimate factor which decides the profitability from farming, procuring cheap but quality fish feed is the prime requirement for any aquaculture activity. As per the decision of 62<sup>nd</sup> Executive Committee of ADAK, convened on 24-01-2023, ADAK decided to explore the possibility of procuring the fish/shrimp feed, directly from the manufacturers by taking dealership. It will ensure affordable fish feed for farmers but without compromising on its quality.

#### 2. SCOPE OF SERVICES TO BE PERFORMED BY THE SELECTED FIRM

The empanelled bidders need to supply fish/shrimp feed at locations under the operational control of ADAK viz., (1) Neyyar dam (Thiruvananthapuram),

- (2) Ayiramthengu (Kollam), (3) Poyya (Thrissur), (4) Ullanam (Malappuram),
- (5) Kallanodu (Kozhikkodu) and (6) Eranholi (Kannur) as specified time to time during the tender period. However, each supply order should be a consignment of a minimum of 11 tons for a given location. The locations and quantity of feed to be supplied will be intimated by ADAK as and when required. The details of feed specification are given in four separate tables in Annexure II, and the participant firm should confirm the compliance of the same by uploading the relevant details.

#### 3. ELIGIBILITY CRITERIA FOR PARTICIPATION

The manufacturing firm who intend to give dealership for the whole or part of the feed items as contained in Annexure II, can participate in the tender. The bidder should also satisfy the following eligibility criteria.

- (a) Should be a ISO certified feed manufacturing firm.
- (b) Should be doing business with in India, at least for the last 5 year period continuously. (A declaration in this regard should be uploaded along with technical documents)
- (c) Should have minimum annual turn over of Rs. 100 Crore in last three financial years.
- (d) Should not have blacklisted by any department/institute under Governmet of Kerala.

Note: ADAK reserves the right to enhance the eligibility criteria or to relax the eligibility criteria on the basis of response from applicants.

Mere fulfilling the eligibility criteria shall not entitle the applicant to be empanelled by ADAK.

#### 4. PREPARATION AND SUBMISSION OF TECHNICAL BID

#### **4.1. PRE-BID MEETING:**

In order to clarify any queries and discuss the issues with respect to the Project, a pre- bid meeting shall be held with the bidders as per the schedule given below,

#### 4.2. SUBMISSION OF BID

- (i) The Technical Bid shall be in the format annexed to this EoI and the bidder would provide all information as per this EoI, and the agency would evaluate only the bids received in the required format.
- (ii) It should be uploaded in e-tender portal by the bidder as per the procedures and guidelines specified thereon within the stipulated time limit.
- (iii) The completely filled up application should be in the format given as Annexure –I with duly signed EoI documents on all pages.
- (iv) Compliance statement for all feed items intended to be supplied should be given by the bidder as Annexure –II.
- (v) The bid document should be in English and in PDF format
- (vi) The authorized signatory of the Bidder shall sign in all the pages of EoI

#### 4.3. VALIDITY OF BIDS

The bids submitted shall be valid for a period of 90 days.

#### 5. OPENING OF BIDS

- 5.1 Bids submitted on or before 21.02.2023 by 5.00 PM (IST) will only be considered. The bid opening authority will not consider any bid submitted after expiry of time and date specified.
- 5.2. Technical Bid will be opened on 22.02.2023 at 2.00 P.M. The authorized representatives of the interested bidders can be present during opening of bids.

#### 6. EVALUATION OF BIDS

- 6.1 'Technical and Financial Evaluation committee' of the Agency will evaluate the Technical bid.
- 6.2. Technical bid will be evaluated as per the criteria given below:
  - (i) Satisfaction of eligibility criteria provided in clause 3 above.
  - (ii) Provided compliance statement as given in Annexure II.

Note: If requested the successful bidders shall furnish the originals of all the documents/certificates/ statements, furnished by him along with bid for verification.

#### 7. EMPANELMENT CONDITIONS:

- a. ADAK reserves the right to appoint one or more firms at a time for supplying feed.
- b. Tenure of empanelment for the feed supply shall be three years which may further be extended on mutually agreed terms and condition, subject to satisfactory performance of the firm.
- c. Decision of ADAK regarding empanelment of applicant shall be final and shall be binding to all the participants.

#### 8. PROCUREMENT PROCEDURES:

- a. Final procurement of feed will be done on inviting closed sealed short-tenders by e-mail, for a duration of seven days, among the members of the empanelled bidders for a minimum quantity of 500 tons at a time and the process will be repeated either after six month period or on fulfillment of the supply order, whichever is earlier and on expiry of the same, the process will be repeated on inviting fresh closed tenders from the empanelled list. Even if, the number of participants among the empaneled list is one, the financial quote of the same will be considered.
- b. The quote with lowest price will be selected for each closed tender.
- c. On receipt of the selection notice the L-1 bidder has to execute an agreement with ADAK in the prescribed format.
- d. Supply order will be awarded based on the requirement arises at ADAK units, and an order of minimum 11 ton per consignment will be ensured.
- e. On receipt of supply order the bidder should effect the delivery within ten days.
- f. If the bidder fails to deliver the same within ten days, without any valid reasons, ADAK can procure the same from other sources and put the firm under black list.
- g. On receipt of consignment, ADAK agrees for the payment within seven working days on receipt of each shipment bill.

#### 9. GENERAL PROVISIONS:

- i. The bidder shall carefully fill the bid and any over writing shall not be permitted. Errors if any in the bid offer shall be corrected by striking out and rewriting clearly and initialed.
- ii. The bidder is not allowed to make any alterations to the Terms & Conditions. For any such alteration, the offer of the bidder is liable to be rejected.
- iii. Conditional bid/offer will not be accepted.

iv. The agency will have liberty to postpone or not execute any procurement and the Bidders shall not be entitled to any compensation or damage for

such postponement or non-execution of the procurement.

v. Any dispute arising out of the provision of this agreement shall be subject to

the jurisdictions of the court at Thiruvananthapuram only and no other court

shall have jurisdiction to entertain any petition, application or suit to resolve

such disputes.
