In exercise of the powers conferred by Sub- sections (1), (3), (4), (5) and (5B) of section 4 of the Kerala Fishermen's Welfare Fund Act, 1985 (30 of 1985) and in partial modification of the Notification issued under G.O.(P) No. 25/2008/F&PD dated 7th May 2008 and published as S.R.O. No. 493/2008 in the Kerala Gazette Extraordinary No. 947 dated 14th May 2008, the Government of Kerala hereby modify the rates of contribution, payable under the said Act, with effect from 01.04.2024 and



consequently make the following amendments in the schedule to the said notification, namely:-

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

Section 4 of Kerala Fishermen's Welfare Fund Act , 1985 (30 of 1985)empowers the Government on the recommendation of the Board to fix the rate of Contribution payable to the Kerala Fishermen's Welfare Fund by various categories of persons such as Fishermen and Owners of traditional crafts, mechanised boats, nets, fish farmers, Prawn filtration area, Prawn Culture Area and Fish Markets Owners. Now Government have decided in partial modification of the Notification issued under G.O. (P) No.25/2008/F&PD dated 7th May 2008 published as S.R.O. No. 493/2008 in the Kerala Gazette Extraordinary No. 947 dated 14th May 2008.

The notification is intended to achieve the above object.
