### ORDER

The Director of Fisheries as per the letter read above, submitted a proposal "Livelihood and Nutritional Support for Socio- Economically backward, active traditional Fishers for conservation of fisheries resources during ban/lean under PMMSY (2023-24). The objectives of the proposal are as follows:

- a) To inculcate the habit of savings among Fishermen
- b) To provide financial assistance to fishermen during lean periods.

2) The beneficiaries of the scheme are the fishermen registered with the Kerala Fishermen Welfare Fund Board and who have enrolled in the Fisheries Information Management System (FIMS), developed by the Department of Fisheries. The total project cost is Rs. 64.641 Crores. The beneficiary contribution is Rs. 21.547 Crore and the matching contribution of Central and State Government is Rs. 43.094 Crore.

3) The Director of Fisheries has requested Administrative Sanction for the Proposal by meeting the expenditure from the Head of Account 2405-00-121-91 (Plan) for the implementation of the scheme, since the Central share is currently being sanctioned by Central government only in a reimbursement mode.

4) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the project " Livelihood and Nutritional Support for Socio- Economically backward, active traditional Fishers for conservation of

fisheries resources during ban/lean under PMMSY(2023-24)" at a total Project cost of Rs. 64.641 Crores, meeting the expenditure from the Head of Account 2405-00-121-91 (Plan) .
