The Director of Fisheries, as per the letter read above, has submitted a project proposal "Medical Camps for Fishermen" at an estimated cost of Rs.16.90 lakh, with the following components and has requested Administrative Sanction for the same.

The total cost envisaged for one camp is Rs. 1,30,000/- and total 13 camps are proposed to be conducted in the state. The project will be implemented with the assistance from the Department of Health, ehealth wing of Health Department, NHRM and Ayush.

- 2) The objectives of the project are as follows:-
- i) To assess the health conditions of the fishermen community and to address the need of established health care within the community.
- ii) To create a health database using e-health so that further planning of the health projects can be undertaken.
- 3) The Department Working Group held on 15/10/2022 examined the proposal in detail and approved the same.
- **4)** Based on the decision of the Working Group, Government are pleased to accord Administrative Sanction for the project "Medical Camps for Fishermen" at an estimated cost of Rs. 16.90 lakh.
- 5) The expenditure for this purpose will be met from the budget provision for the financial year 2022-23, under the Head of Account '2405-00-103-80 (P)'.
