- b. The instructions stipulated in Cir.No.08/18/Fin dated 30.1.2018, Cir.No.84/2008/Fin dated 09.12.2008 and G.O.(Ms) No.93/2020/Fin dated 11.9.2020 shall be complied with.
- c. The Director of Fisheries shall furnish duly authenticated detailed component wise statement of Expenditure and utilisation Certificate in the prescribed formats appended to the G.O.(Ms) No.4/2020/Fin dated 09.01.2020.
- d. If there is un-utilised amount at the end of this financial year that should be refunded to the government during the financial year itself.
