ORDER

As per the letter read above, the Director of Fisheries has submitted a proposal for the Reconstruction of Fishermen Colonies for an amount of Rs.736 lakh from the Head of Account 4405-00-103-93 (P) and has requested to accord Administrative Sanction for the same. The objectives of the project are as follows:

- Safety and Structural Integrity: Ensure that the reconstructed and renovated houses are structurally sound and meet modern safety standards to protect residents from natural disasters and hazards.
- **Housing Rehabilitation:** Reconstruct damaged houses to provide suitable and safe living conditions for residents, addressing issues related to structural damage, water leakage, electrical systems etc.
- **Habitability Improvement:** Enhance the habitability of the houses by addressing structural issues, repairing damages and improving the overall quality of the living spaces.
- **Community Well-being**: Improve the overall quality of life for the residents by creating comfortable, functional, and aesthetically pleasing living spaces.
- Safety Enhancement: Ensure that the renovated houses meet safety standards and are resilient against potential natural disasters or hazards such as earthquakes, floods or storms.
- Amenities and Infrastructure: Upgrade basic amenities such as water supply, sanitation facilities, electricity and other relevant systems to provide residents with a comfortable and functional living environment.
- Community Spaces: Create communal spaces within the housing area that encourage

interaction, socialization and community bonding among residents.

- Cultural Sensitivity: Respect and integrate any cultural or architectural elements that hold significance for the residents, preserving the identity and heritage of the community.
- **Timely Execution:** Set clear project timelines and milestones to ensure that the construction work is completed within the specified time frame.
- Quality Assurance: Maintain high renovation standards to ensure that the houses are not only visually appealing but also built to last.
- **Health and Hygiene:** Ensure that the renovated houses provide a clean and hygienic environment, promoting the health and well-being of the residents.

PROJECT BENEFICIARIES:

- i)Registered fishermen.
- ii)Pensioner should also be considered.
- iii)Should have the documents of ownership of house.
- 2) The project will help to improve the resilience of the coastal community and strengthen their adaptive capacity and thus ensure the safety of coastal households living in that area. The families who were living in dilapidated houses will be relieved off their sufferings and will be able to lead a normal life. Safe houses to the families will lead to elevated confidence level and increased morale in the coastal community.
