**ORDER**

As per letter read as 1<sup>st</sup> paper above, mother sanction for Rs.25 crores has been allocated from Government of India for the financial year 2024-25 for development of fisheries in the State under the PMMSY scheme to the PMMSY account linked to KL-237 which is shared in 60: 40 funding pattern.

The Director of Fisheries vide letter read as 2<sup>nd</sup> paper above has informed that since the central fund of 25 crores is allotted, the corresponding state share will be 16.667 crore, thus total an amount of 41.667 crores needs to be sanctioned for the time bound and smooth implementation of the project under PMMSY SLS-237. And requested to accord sanction for the utilization of Rs. 41.667 crore for the implementation of the PMMSY scheme through SNA SPARSH and sanction for the re-appropriation of funds in the respective Heads of Accounts.

As per G.O. read as 3<sup>rd</sup> paper above, Government have accorded sanction for the Re-appropriation of a sum of Rs.16,66,70,000/- (Rupees Sixteen Crore Sixty Six Lakh Seventy Thousand Only) under the head(s) of account 22405-103-77-121.

As per G.O. read as 4<sup>th</sup> paper above, Government have accorded sanction for the Additional authorisation for an amount of Rs.25,00,00,000/- (Rupees Twenty Five Crore Only) under the head(s) of account 4405-00-104-36-02-PV.

In these circumstances, Administrative Sanction is hereby accorded for the utilisation of an amount of Rs. 41.667 crore for the implementation of the PMMSY scheme from the above Heads of Accounts.

The Director of Fisheries shall take further necessary action as per Circular read as 5<sup>th</sup> paper above and also take timely steps to regularise this additional expenditure through Re-appropriation of Savings within the Grant/Supplementary Demands for Grants before the close of the current financial year.
