ORDER

As per the letter read above, the Director of Fisheries has submitted a proposal for the project 'Providing Deep Water Line Fishing Gears to Traditional Fishermen of Kerala' at an estimated cost of Rs.132.50 Lakh and requested to issue administrative sanction for the same.

- 2) The objectives of the scheme are as follows:-
 - 1. To equip the traditional fishermen for deep sea fishing.
 - 2. To promote sustainable fishing practices
 - 3. To reduce fishing pressure in the territorial waters
 - 4. To enhance the sea export earnings of the country.
 - 5. To ensure maximum economic returns to the fishermen.
 - 6. To enhance socio-economic status of traditional fishermen.
- 3) The traditional fishermen group of 5-10 members who have traditional skill for Hook and line fishing and are now involved in deep sea fishing will be selected as the beneficiaries from any of the marine fishing villages of Kerala. Only traditional/artisanal fishermen groups are eligible and the beneficiary shall possess valid ownership certificate in the name of group leader, Registration certificate under Real craft,

fishing license and Biometric cards of fishers/QR coded Aadhar card.
