ORDER

The Director of Fisheries, as per the letter read as 1st paper above, submitted a Project proposal "Interest subvention to fishermen for fishing inputs and to women for fish vending" for a total outlay of Rs.341.03 lakh and requested administrative sanction for the project.

- 2) The components of the project are as follows:
- i. Interest subvention to fishermen for procurement of fishing inputs through schemes of NCDC/NBCFDC/NMDFC/NABARD/like Financial agencies.
- ii. Interest subvention to women vendors for fish vending.
 - **3)** The objectives of the project are the following:
- a) To safe guard, the traditional registered fishermen having membership in primary fishermen co-operatives, from incurring heavy input cost by way of interest subvention.
- b) To make them able to avail loans interest free from Matsyafed under NCDC assisted schemes for procuring fishing inputs.
- c) To make fishermen owners of the fishing units without investing too much money and that too within a short period of time.
- d) To bring fishermen to beach level auction system of Matsyafed.
- e) To attract more traditional fishermen towards a structured platform where they are not exploited.

- f) To help the fisher women to effectively carryout their livelihood activities to become self-reliant.
- g) To make the fisher women free from unserviceable debt and exploitation.
- h) To improve the socio-economic condition of fisher women and to reduce poverty from among the fisher folk.
- i) To assist the fisher women and make them engaged in income generating activities.
- j) To sharpen their financial management skills by Capacity Building.
- k) To generate more employment opportunities for women in fishing communities.
- 1) To create awareness among fishermen on the need of social participation and institutionalization.
- **4)** The Departmental Working Group held on 26/07/2022 examined the proposal in detail and approved the proposal.
- 5) Considering the decision of the Departmental Working Group, Government are pleased to accord Administrative Sanction for the Project "Interest subvention to fishermen for fishing inputs and to women for fish vending" at a total cost of Rs. 341.03 lakh (Rupees Three crore Forty One lakh and Three thousand only).
- 6) The expenditure for this purpose will be met from the budget allocation for the financial year 2022-23, under the Head of Account 2405-00-103-80 (P).
