As per the letter read above, the Director of Fisheries has submitted a proposal for the project 'Monitoring of KMFR Act at Fishing Harbours' at an estimated cost of Rs.160 Lakh and requested to issue administrative sanction for the same.

2) The objectives of the scheme are as follows :-

1. To augment marine fish production of the State.
2. To ensure sustainable development of marine fisheries.
3. To ensure responsible harvest and post-harvest operations.
4. To ensure socio-economic development of fishermen.
5. To prevent the violation of KMFR Act.
6. To ensure the Hygienic Handling of fishes at harbours.
7. To provide weather warning information to sea going fishermen.

3) The marine fishermen of Kerala State will be the direct beneficiaries of the project.
