The Director of Fisheries, as per the letter read above, has requested to release an amount of Rs. 52.725 crore from the Head of account '2405-00-121-93 (P)' for the implementation of 'Livelihood and Nutritional Support for Socio- Economically backward, active traditional fishers for conservation of fisheries resources during ban/lean period (Savings Cum Relief Scheme)' for the year 2022-23.
