ORDER

As per the G.O read as first paper above, Administrative Sanction was accorded for the implementation of "Alternative and Supportive Livelihood Opportunity to Fisher women of Kerala 2021-22", with a total project outlay of Rs. 1500 Lakhs under the Head of Account 2405-00-103-80 (P). Major important components under the project are Development of Micro Enterprises (DME) benefiting 750 fisher women and formation of Joint Liability Groups (JLG) covering 2000 fisher women.

2) As per the G.O read as 2nd and 3rd papers above, an amount of Rs. 1000.75 lakhs has already been released to the Executive Director, SAF being the first and second installments for the implementation of the project.

3) As per the letter read above, the Director of Fisheries has requested to revise the Administrative Sanction, already issued vide G.O read as first paper above and to release an amount of Rs. 380 Lakhs Rupees from the Head of Account 2405-00-103-80 (P) to the PSTSB A/c No.799012700000787 of Executive Director, SAF maintained at Sub Treasury Aluva, for the completion of the project.

4) Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for the project "Alternative and Supportive Livelihood Opportunity to Fisher women of Kerala" for an amount of Rs.1500 lakhs (Rupees one thousand and five hundred lakh only) under the Head of Account 2405-00-103-80 (P) for the current financial year.
