ORDER

As per letter read as first paper above, the Director of Fisheries has submitted a project proposal for Capacity Building Programme for 2023-24 at an estimated cost of Rs. 20 Lakh (Rupees Twenty Lakh only) under the head of account 2405-00-109-91(PV) and has requested for providing administrative sanction.

2. The objectives of the training programme are detailed below:-

- a. To improve the skills and professional competency of extension functionaries of Fisheries Department.
- b. To ensure human resource development in fisheries subjects.
- c. To develop a professional and efficient civil service that is responsive to the citizens.
- d. To update on reforms and initiatives in governance.
- e. To impart skills and attitudes and ethics in personal and public relationship.
- f. To upgrade the practical knowledge.
- g. To enrich them with the latest technology and knowledge.
- h. To provide opportunities for officers to get direct interactions with the team of scientists/experts in leading institutes of the country and the world.
- i. To impart regular in-service training at all levels including technical, professional and scientific personnel.

3. The components of the training programme are as follows:

A) Training programme to functionaries:-

1) Technical training inside the state:-

- i) Fish disease management (3 days training to 15 technical staff - Seed Inspectors conducted in association with PMFGR-ICAR-NBFGR).
- ii) Motivation and professional excellence training for Assistant Directors (3 days training to 20 officials at NIFAM, Aluva).
- iii) Motivational training to Fisheries Extension Officers (3 days training to 30 officials at NIFAM, Aluva).
- iv) Training programme on KCS Act & Rule including Arbitration, Execution & Liquidation procedures for co-operative officials (3 days training to 20 officials at Institute of Co-operative Management).
- v) Training programme on Co-operative Accounting to Fishery Co-operative officers (3 days training to 25 officials at Institute of Co-operative Management).

2) Staff Training Programme:- The programme proposes to provide 90 days training programme to 35 officers in the categories of Fisheries Extension Officer, Assistant Fisheries Extension Officer & Fisheries Officer for imparting knowledge and skill for enhancing productivity and effective service delivery. The training is to be conducted at Fisheries Training Centre, Aluva

3) Technical Training out side the state :-

- i) Hatchery production and farming of Pompano & Cobia- Hands on training programme on hatchery production, cage farming and farming practices. 4 days training programme for 10 officials at the research centre of CMFRI, Mandapam.
- ii) Hatchery production and farming of Milk Fish & Mullets- Hands on training in updated techniques for hatchery production of milk fish and mullet. 5 days training programme for 10 officials at CIBA, Chennai.

4) Interstate exposure visit to:-

- i) 6 Senior officials will be deputed for 3 days visit at Central Inland Agricultural Research Institute, Port Blair, Andaman & Nicobar Islands.
- ii) 6 Senior officials will be deputed for 3 days visit at Central Inland Fisheries Research Institute, Barackpore, Kolkata.
- iii) 6 Senior officials will be deputed for 3 days visit at Central Marine Fisheries Research Institute, Vishakapatnam.

The duration of 3 days is exclusive of the travel time.

B) Training programme to beneficiaries:-

Aquaculture Training to Educated Youth : The programme proposes to conduct training 8 months training to 6 number of selected youth who belongs to the age group from 20-30 years, preferably from the fishermen community who are having Degree/ VHSC qualification in Aquaculture subjects.
