## **ORDER**

As per the letter read as 1 st paper above, Government of India had sanctioned Central share of Rs.69,16,63,000/- (Rupees Sixty nine crore sixteen lakh and sixty three thousand only) to Government of Kerala under PMMSY scheme.

- 2. As per letter read as 2 <sup>nd</sup> paper above, the Chief Engineer, Harbour Engineering Department had submitted the details of their budget allocation for the Financial Year 2023-24 in the Head of Account 4405-00-104-36-01(P)-Central share and 4405-00-104-36-02-(P)State share, in respect of PMMSY scheme and informed that the central share towards the Fisheries Infrastructure projects under the PMMSY implemented by the Harbour Engineering Department is Rs. 2343.30 lakh and its corresponding state share of Rs. 1562.20 lakh under PMMSY 2023-24 has to be released from Government of Kerala. Hence requested for Additional Authorization for an amount of Rs.3905.5 lakh.
- 3. The Director of Fisheries, as per letter read as 3 <sup>rd</sup> paper above has informed that the Harbour Engineering Department had fully expended the allocated amount for the Financial Year 2023-24 in the Head of account and there is no sufficient balance. Hence requested to release a total amount of Rs.3905.5

lakh (Central share of Rs.2343.30 lakh and State share of Rs.1562.2 lakh) as additional authorization, as requested by Harbour Engineering Department and to transfer credit the amount from the concerned Head of Account to PMMSY Single Nodal Account No.921010023050209 maintained by Director of Fisheries at Axis Bank, Malayattoor Chambers, Nalanchira, Thiruvananthapuram (IFSC-UTIB0003736).

- 4. Government have examined the matter in detail and are pleased to release a total amount of Rs. 3905.5 lakh additionally authorizing Rs. 843.3 lakh under the h/a 4405-00-104-36-01 and Rs. 562.2 lakh under the h/a 4405-00-104-36-02 over the budget provision of Rs. 1500 lakh and Rs. 1000 lakh respectively earmarked for the Financial Year 2024-25 as per the Government Order read as 4<sup>th</sup> paper above.
- 5. The ceiling limit of the respective HoAs is enhanced to 100%. The amount should be transfer credit to the Single Nodal Account (No.921010023050209 IFSC Code.UTIB0003736) of PFMS opened for Directorate of Fisheries in Axis Bank, Nalanchira, Thiruvananthapuram.
