## **ORDER**

As per the Government order read as first and fourth paper above, Government had issued orders setting up Matsyabhavans in the State. As per the Government order read as fifth paper above, Government has issued orders fixing the jurisdiction of 67

Matsyabhavans. Each Matsyabhavan has one Fisheries Extension Officer and sufficient numbers of non-gazetted supporting staff. Vide the Government order read as third paper above, the financial powers of the Joint Director, Deputy Director & Assistant Director of Fisheries Dept. has been enhanced in accordance with the Government order read as second paper above. The Director of Fisheries vide letter read as sixth paper above submitted proposal to delegate financial powers to Fisheries Extension Officer s for the smooth functioning of the Matsyabhavans.

2. The Empowered Committee meeting held on 11.03.2024 discussed the proposal in detail and decided to delegate financial powers to Fisheries Extension Officers in line with the Government orders read as second & third paper above. As such, Government are pleased to delegate financial powers to Fisheries Extension Officers in the Fisheries Department as detailed below.
