As per the letter read as 1st above, the Director of Fisheries had submitted the 9 "Modern Fishing Villages" projects of Kerala State Coastal Area Development Corporation, for an amount of Rs. 6698 lakh, which have already been included in the PMMSY Annual State Plan 2023-24 for approval and onward submission to NFDB and Government of India . The proposals were approved in the SLAMC meeting held on 24.8.23 and submitted to Government of India.
