## **ORDER**

As per the Government order read as 1<sup>st</sup> paper above, Government have prohibited the use of bottom trawl in the sea along the entire coastline of the Kerala State for a period of 52 days with effect from the 10<sup>th</sup> of June 2024 to 31<sup>st</sup> of July 2024.

- 2) In order to support the workers of the mechanized boats and allied workers including peeling workers, the Director of Fisheries has submitted a proposal, for providing free ration for 52 days, during the trawl ban period 2024 and has requested sanction for Rs.5 lakhs (Rupees Five lakhs only) from the Head of Account 2405-00-121-95 (NP), for implementation of the proposal.
  - **3)** Objectives of the proposal are as follows:
  - 1. To provide relief to the workers of mechanized boats and allied workers including peeling workers, who lose employment during the period of ban on bottom trawling.
  - 2. To relieve the fishermen from the exploitation of money lenders.
  - 3. To give nutritional support to the family of fishermen and allied fish

4) Government have examined the proposal in detail and are pleased to accord Administrative Sanction for an amount of Rs.5 lakhs (Rupees five lakhs only) under the Head of Account 2405-00-121-95 (NP), for providing free ration to the workers of mechanised boats, peeling workers and allied workers in the fishing harbours during trawl ban period 2024.
