As per the letter read as Ist above, the Director of Fisheries has submitted a proposal for the project 'Interest Subvention to Fishermen for Fishing Inputs and to Women for Fish Vending' at an estimated cost of Rs.300 Lakh and requested to issue administrative sanction for the same.

- 2) The objectives of the scheme are as follows:-
- 1. To safeguard the traditional registered fishermen having membership in primary fishermen co-operatives from incurring heavy input cost by way of interest subvention.
- 2. To make them able to avail loans interest free from Matsyafed under NCDC assisted schemes for procuring fishing inputs.
- 3. To make fishermen owners of the fishing units without investing too much money and that too within a short period of time.
- 4. To bring fishermen to beach level auction system of Matsyafed.
- 5. To attract more traditional fishermen towards a structural platform where they are not exploited.
- 6. To help the fisher women to effectively carryout their livelihood activities to become self-reliant.

7. To make the fisher women free from unserviceable debt and exploitation.

- 8. To improve the socio-economic condition of fisherwomen and to reduce poverty from among the fisher folk.
- 9. To assist the fisherwomen and make them engaged in income generating activities.
- 10. To sharpen their financial management skills by Capacity Building.
- 11. To generate more employment opportunities for women in fishing communities.
- 12. To create awareness among fishermen on the need of social participation and institutionalization.
- 3) The Traditional registered fishermen having membership in primary fishermen co-operative societies affiliated to Matsyafed and the registered women fish vendors belonging to artisanal fishermen families who are engaged in fish vending will be the beneficiaries of the scheme.
